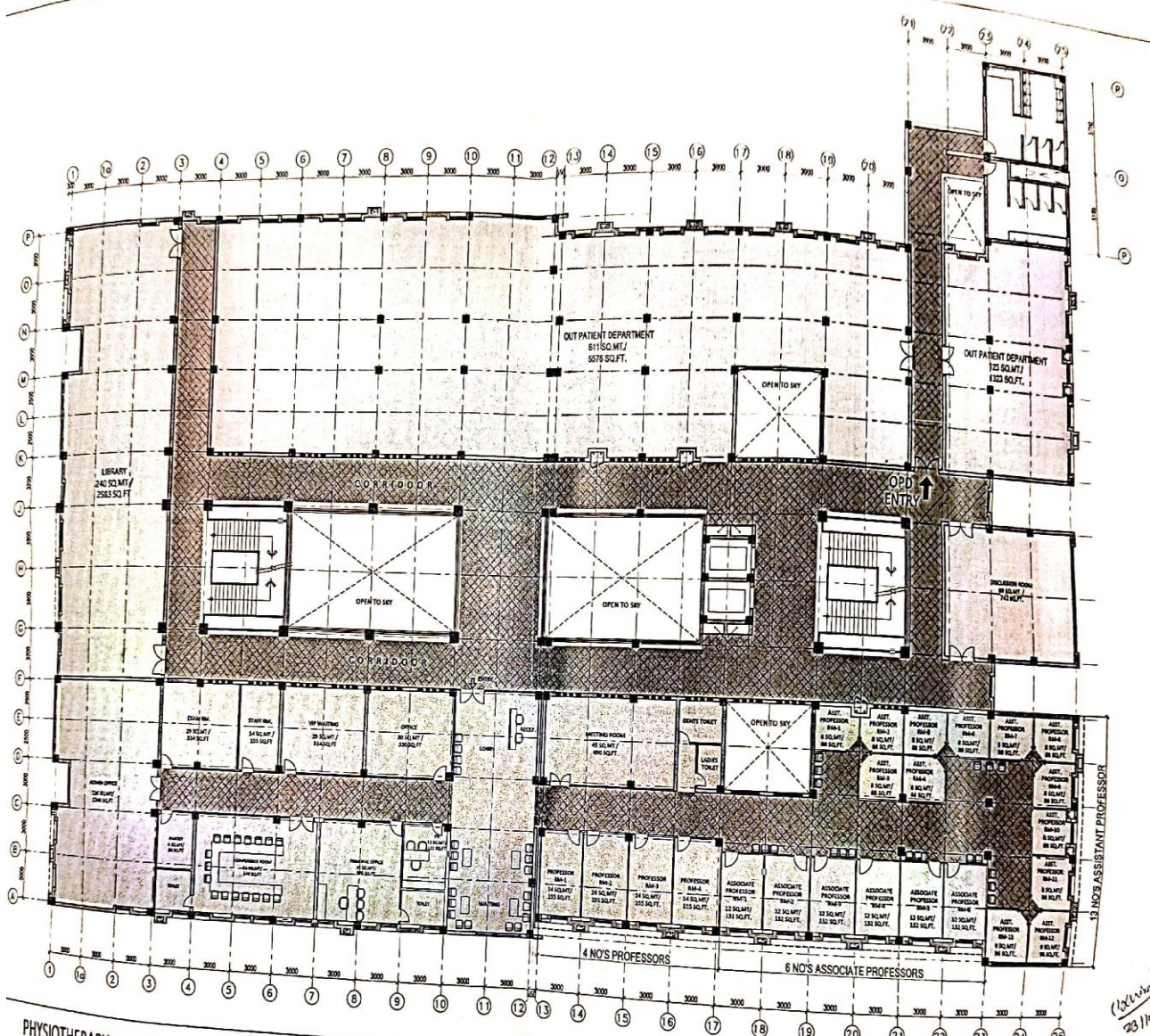


STRATEGIC PLAN DOCUMENTS

THIS AFFILIATION AGREEMENT is entered into by and between

College of Physiotherapy, a constitute of Dr. Vithalrao Vikhe Patil Foundation, Ahmednagar (hereinafter "Educational Institute") and, the esteemed **Community Development Trust's Asha Kendra, Puntamba Ahmednagar**. Together these are the "the Parties" to this Memorandum of Understanding. The Parties agree that their respective organizations and relevant contracted agencies will endorse and adhere to this Memorandum of Understanding at all levels of operations.

BACKGROUND

Physiotherapy aims to improve and maintain the wellbeing of an individual in society by providing interventions that minimize the impact of disability, and promote independence and participation in a range of activities and life areas. It plays a critical role in supporting growth and development and access to learning, recreation and work. For this reason, access to well-planned, responsive and targeted physiotherapy services for those individuals who need them is vital for maximizing their potential to achieve successful long term social, educational and vocational outcomes.

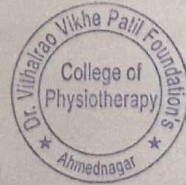
1.1. Scope of the Memorandum of Understanding

WHEREAS, The Educational Institute desires to provide clinical exposure to its Students enrolled in Bachelor and Masters of Physiotherapy Program

WHEREAS, The Asha Kendra(Stroke Centre) is willing to make available its facilities and resources for educational training and clinical experiences to physiotherapy students which will necessarily include provision of physiotherapy services and assistive technology/equipment services ("the Services") for Patients.

THEREFORE, in consideration of the mutual covenants contained herein, the Educational Institute and Asha Kendra agree upon as follows:

- The best interests of the neuro disease patients are the primary concern and purpose of the Services.
- The Parties will develop and foster collaborative working relationships and make the best use of available resources to provide the Services.
- Best practice and professional standards will be adhered to provide the Services.
- The Parties agree to work flexibly together and to provide the Services.
- Neither party, in performing its responsibilities and obligations under this Agreement, will discriminate against any person because of said person's race, creed, religion, national origin, sex or age.
- This Memorandum of Understanding and the Operational Guideline will serve as the basis for Local Level Agreements. The Local Level Agreements will outline how health and education services will work together to deliver quality services.



1.2. Confidentiality

The Parties acknowledge that disclosure of information is subject to the Official Information Act 1982, the Privacy Act 1993 and the Health Information Privacy Code 1994.

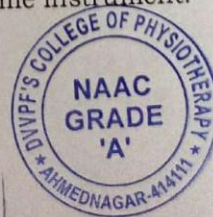
Each Party will consult with the other before disclosing information relating to operational matters covered by this Memorandum of Understanding, as required by law, and each Party will only disclose that information in accordance with the law.

1.3 The Term and Termination

- The term of this Agreement shall be for a period of five (5) years from the date of signing.
- This Memorandum of Understanding may be varied from time to time by mutual agreement between the Parties. With each variation, a new document including the variation(s) will be produced, agreed, and then signed and distributed by the Parties.
- **This Agreement may be terminated as follows:**
 - In the event Community Development Trust's Asha Kendra ,Puntamba Ahmednagar shall mutually agree that this Agreement may be terminated on terms and date stipulated therein.
 - This Agreement may be terminated by either party with or without cause by delivering a written notice of termination to the other party at least thirty (30) days prior to such early termination.

1.11. Execution

This Agreement and any amendments thereto shall be executed in duplicate copies on behalf of Community Development Trust's Asha Kendra by an official of each, specifically authorized by its respective Board to perform such executions. Each duplicate copy shall be deemed an original, but both duplicate originals together constitute one and the same instrument.

This is to bring to your kind notice that, Dr. Vithalrao Vikhe Patil Foundation's College of Physiotherapy, Ahmednagar (Maharashtra) is working for the treatment of patients with Spinal Cord Injury since last 10 years on a regular basis. We are providing rehabilitation to each of these patients for an average of 9-10 months. The patients are admitted in our parent hospital Dr. Vikhe Patil Memorial Hospital Ahmednagar only for the treatment of Physiotherapy.

Though the hospital is public trust with very minimal charges, long duration of stay makes it difficult for these patients to continue rehabilitation after a specific time period due to financial restraints. This prevents their chances of getting as much possible recovery as possible and hence results in greater morbidity. Telerehabilitation sessions were conducted for SCI patients during COVID-19 pandemic situation; through this telerehabilitation session we have received good responses from the patients and few of them are admitted in our hospital for holistic rehabilitation.

The State Spinal Injury center will be a boon for these patients as it will take care of the financial constraints to a certain extent and will enable them to continue with rehabilitation till maximum recovery possible. This might enable them for some vocational training and/or employment and may improve their quality of life in future.

You are requested to consider our proposal and give us the opportunity to serve these patients in a more efficient manner.

1. Background: Spinal cord Injury is a disabling condition making the individual partly or fully dependent on others for daily needs or economical issues. Rehabilitation of these patients is both costly as well as a time consuming process. Often patients from rural area have limited resources and hence unfortunately have significant morbidities leading to poor quality of life along with being a burden on family.

Better rehabilitation services at an affordable cost will assist these patients to be included in the mainstream of society by providing them an opportunity to maximise their existing potential.

1.1 Description of Problem: Ahmednagar district is a largest district of Maharashtra State in western India. Area of Ahmednagar is 17,413Km²(6,723sqml); with population in 2021 is 4,861,397 (estimates as per aadhar uidai.gov.in Dec 2020 data). It has an average literacy rate of 84%, higher than the national urban area average of 79.9% which is a positive aspect about the locals. The locomotor disability that too due to SCI forms a major bulk of the disabled population of the district. Spinal cord injury is a devastating condition which makes an individual paralysed and makes him dependent on others. However, with rehabilitation there is partial improvement in the condition these patients. But it requires long term care and rehabilitation which needs these patients to stay at the hospital for longer time periods. In spite of being the largest district, Ahmednagar does not have its own SCI centre. The nearest centre is in Pune and Mumbai (distance between Ahmednagar to Pune is 121.3Km & between Mumbai is 253.6Km) which being metropolitan cities makes their stay a costly affair as one caretaker is always required.

1.2 Objectives:

1. To provide Early Intervention for Spinal Cord Injury Patients.
2. To make available the facility of physiotherapy treatment at low cost.
3. To provide assistive devices, provision/fitment of assistive devices & follow up / repair of assistive devices.
4. To reduce the morbidities associated with SCI
5. To provide quality care to these patients.

1.3 Review of Work already done: At present, daily 6-7 patients are being treated at our Physiotherapy OPD all of which are admitted in the parent hospital along with other

patients. Patients are treated twice in a day at physiotherapy OPD for which they need to be transported from ward to OPD which creates administrative issues sometimes. . There is no separate area or rehabilitation ward. Because of which physiotherapy related equipment's or instruments cannot be kept there which can otherwise be used by these patients at an appropriate time other than dedicated therapy times. This stay in general ward attracts regular charges as other patients, though minimal, but gets converted into a big amount due to the long stay required for rehabilitation. Also chances of getting Hospital acquired infection also increases.

Physiotherapy OPD is equipped with all basic instruments required for rehabilitation. However, advanced equipment's are not available due to poor financial returns from patients, for which patients can also not be blamed as they are usually from lower socioeconomical status. Parent hospital also have dedicated Prosthetic & Orthotic unit which provide required assistive devices to these patients at affordable cost & is readily available for repair of minor wear & tear of these devices.

In COVID- 19pandemic situation patients were unable to come for physiotherapy treatment so for them we have started Telerehabilitation session & follow up was taken. More than 25 patients were treated through Telerehabilitation session; we had conducted telerehabilitation session for different SCI associations also; which was formed by SCI patients, where all over Maharashtra SCI patients are connected together.


1.4 Strength & Weakness: Adequate manpower in the form highly qualified therapists with the rank of Professor, Associate Professors, Assistant professors along with Post graduate students and interns is the biggest strength of our unit.

However, Lack of space and advanced equipment, inability to provide cost effective treatment are some of the weaknesses which may be overcome by this project which will enhance the quality of life of these patients.




