

PREAMBLE

The National Mission on Education through Information and Communication Technology (ICT) has been envisaged as a Centrally Sponsored Scheme to leverage the potential of ICT, in teaching and learning process for the benefit of all the learners in Higher Education Institutions in any time anywhere mode.

It seeks to bridge the digital divide, i.e., the gap in the skills to use computing devices for the purpose of teaching and learning among urban and 3 rural teachers/learners in Higher Education domain and empower those. This will make best use of ICT for teaching and learning.

OBJECTIVES

- Promote generation of e-Content in all subjects Pre clinical para clinical
- Develop teachers' and experts' resources in e-Content creation
- Make available the e-Content to students through various delivery modes for formal and education, for supplementing and complementing the process of teaching and learning

e-CONTENT MODULE & CONTENT DURATION

Content duration has been estimated on the basis of the number of hours that are required to transact the content in the classroom. For example 1 hrs. or 45 min Similarly, duration of Video programmes produced by the Programme Developer concerning each module shall be about 45 minutes.

All e content modules will be submitted to committee of e-content by teachers & PG Students. The committee will appoint experts from internal & external institute of Health Sciences Course for verification & validation of modules. The committee will ensure text lecture, video and material of e-content & other course material of e-content shall be as per the policy.

MONITORING COMMITTEE

The appointed committee shall call meeting with all yr. coordinator, & all subject teacher incharge to screen the proposal of e- content. The committee shall be responsible for taking decision regarding e-content development for every e-content module which will be utilize for current academic year.

Pilot module will be prepared by the committee in every new academic year. After the approval of pilot module by chairman of the committee it will be circulate among the teachers and year coordinator. So that all the involved teacher of 1st,2nd,3rd and 4th Year& and PG teachers are instructed to submit e- content module within a month for current academic year as per the produced pilot module.

QUALITY CONTROL

Content authenticity shall be the responsibility of the committee however, technical quality checking shall be responsibility of maintenance dept. Further, issues consenting copy right aspect, intellectual property right are to be taken care by teachers / year coordinator the final product / module shall be previewed and approved before making it available to student however the general quality e -module /e- content will be monitor by committee
